NOTE: DO NOT TIGHTEN ANY CLAMPS OR BOLTS UNTIL THE LAST STEP!

- 1) REMOVE THE EXHAUST SYSTEM AT THE CLAMP BEHIND THE CONVERTER LEAVING ONLY THE ORIGINAL Y PIPE, RUBBER MOUNTS, AND CATALYTIC CONVERTER ON THE TRUCK.
- 2) SLIP THE FRONT PIPE INTO PLACE, AND MATCH UP THE NOTCH ON THE FRONT PIPE TO THE NOTCH PIN. WITH THE TAIL PIPES IN THE REAR OF THE MUFFLER, HOLD UP THE MUFFLER AND TAIL PIPES IN A POSITION THAT CLEARS ALL CHASSIS COMPONENTS. MARK THE FRONT PIPE—SEE NOTE ON LENGTH TO CUT. MAKE SURE TO ACCOUNT FOR AT LEAST 2" OF THE PIPE TO GO INTO THE MUFFLER. CUT THE FRONT PIPE.

NOTE: THE EXTENSION PIPE WILL FIT THE EXTENDED CAB SHORT BOX AND LONG BOX TRUCKS WITHOUT CUTTING. ON ALL OTHER VEHICLES THE EXTENSION PIPE WILL NEED TO BE CUT FROM THE 3" O.D. END (THE END THAT IS NOT SHRUNK) AS NECESSARY. FOR REGULAR CAB SHORT BOX (119" W.B.) CUT OFF APPROXIMATELY 18", AND CUT OFF APPROXIMATELY 3" FOR REGULAR CAB LONG BOX (135" W.B.). FOR EXTENDED CAB LONG BOX (155" W.B.) YOU WILL NEED THE EXTRA 21" EXTENSION PIPE AND 3" CLAMP, WHICH ARE NOT NEEDED ON THE SHORTER WHEEL BASE TRUCKS.

- 3) USE THE 2-1/2" CLAMP TO ATTACH THE EXTENSION PIPE TO THE CONVERTER PIPE, AND FOR EXTENDED CAB LONG BOX, INSTALL THE 21" EXTENSION PIPE TO THE LONGER EXTENSION PIPE USING A 3" CLAMP.
- 4) SLIDE THE 3" HANGER CLAMP OVER THE EXTENSION PIPE. ATTACH THE 3" HANGER CLAMP TO THE O.E. RUBBER MOUNTING BRACKETS ABOVE THE EXTENSION PIPE ON BOTH SIDES OF THE PIPE.
- 5) USE A 3" MUFFLER CLAMP TO ATTACH THE INLET OF THE MUFFLER AND THE EXTENSION PIPE TOGETHER.
- 6) INSTALL THE SHORT TAIL PIPE TO THE OUTSIDE OUTLET (PASSENGER SIDE) USING A 2-1/2" CLAMP.
- 7) INSTALL THE LONG TAIL PIPE TO THE INSIDE (NEAREST TO THE DRIVE SHAFT) OUTLET OF THE MUFFLER USING A 2-1/2" CLAMP.
- 8) INSTALL THE DUAL 2-1/2" WELDED CLAMP TO THE TAIL PIPES JUST OUTSIDE OF THE FRAME.
- 9) LOCATE OR DRILL A 5/16" HOLE IN THE FRAME ABOVE THE LEFT TAIL PIPE JUST AFTER THE BEND AND INSTALL THE BR91930 SWINGER HANGER TO THE FRAME USING A 5/16" BOLT, NUT, LOCK WASHER, AND FENDER WASHERS. THE HANGER WILL NEED TO BE BENT AT A 90 DEGREE ANGLE AT ABOUT JUST BELOW THE SECOND HOLE FROM THE TOP, BUT CAN BE ADJUSTED TO YOUR PREFERRED HEIGHT. USE A 2-1/2" CLAMP TO CONNECT THE LEFT TAIL PIPE TO THE BR91930 SWINGER HANGER.
- 10) TIGHTEN ALL CLAMPS AND BOLTS AND CHECK FOR CLEARANCE OF THE FRAME, BODY, AND BRAKE AND FUEL LINES.


