

## **INSTRUCTIONS FOR KIT #4005760 4" DIESEL KIT CAT-BACK KIT**

FITS: 2001-2005 FULL-SIZE GM DURAMAX 3/4 & 1 TON W/6.6L TURBO DIESEL, 2WD & 4WD, CREW CAB MODELS (short bed = 153", long bed = 167" wheel bases), THIS IS A CAT-BACK KIT FOR VEHICLES WITH THE CATALYTIC CONVERTER.

**NOTE:** DO NOT TIGHTEN ANY CLAMPS OR BOLTS UNTIL THE LAST STEP! READ THESE INSTRUCTIONS FULLY AND THOROUGHLY BEFORE YOU BEGIN.

1) YOU WILL NEED TO CUT THE EXHAUST OFF 4" FROM THE REAR OF THE 4-BOLT RECTANGULAR FLANGE AFTER THE CONVERTER. USE A RECIPRICATING SAW OR HACK SAW TO DO THIS. REMOVE ANY BURRS LEFT AFTER CUTTING.

2) INSTALL THE FRONT EXTENSION PIPE TO THE O.E. CONVERTER PIPE USING A 3-1/2" CLAMP. IT IS THE EXTENSION PIPE WITH 3 BENDS IN IT, ID END IS THE INLET. THE EXTENSION PIPE IS BENT TO CLEAR THE CROSS MEMBER. INSTALL THE WIRE HANGERS THAT ARE ON THE FRONT EXTENSION PIPE TO THE O.E. RUBBER HANGER MOUNTS FOR THE CREW CAB SHORT BOX. FOR THE CREW CAB LONG BOX, THE REAR HANGER ON THE FRONT EXTENSION PIPE IS NOT USED. YOU MAY EITHER CUT IT OFF OR LEAVE IT UNUSED.

3) THE MIDDLE EXTENSION PIPE WILL FIT THE CREW CAB LONG BOX MODELS WITHOUT CUTTING. ON THE SHORT BOX MODELS, YOU WILL NOT NEED THIS 17" ID/OD EXTENSION PIPE. USE A 4" CLAMP TO CONNECT THE MIDDLE AND FRONT EXTENSION PIPES (IF NECESSARY). ATTACH THE HANGER ON THE 17" ID/OD EXTENSION PIPE TO THE O.E. HANGER ALONG SIDE THE PIPE.

4) INSTALL THE MUFFLER TO THE EXTENSION PIPE USING A 4" CLAMP. NOTE: THE EXHAUST SHOULD FLOW OVER, AND NOT DIRECTLY INTO, THE LOUVERS OF THE MUFFLER.

5) INSTALL THE TAIL PIPE TO THE MUFFLER USING THE FRONT 4" HANGER CLAMP (SEE DRAWING) AT THE CONNECTING POINT OF THE TAIL PIPE AND MUFFLER. INSTALL THE WIRE HANGER THAT IS ON THE HANGER CLAMP TO THE O.E. RUBBER MOUNT ABOVE.

6) INSTALL THE REAR 4" HANGER CLAMP TO THE TAIL PIPE BEFORE THE LAST BEND AND BELOW THE O.E. RUBBER HANGER MOUNT. INSTALL THE WIRE PORTION OF THE HANGER TO THE O.E. MOUNT ABOVE.

7) FOR THOSE WITH DUALY MODELS, YOU WILL NEED TO INSTALL THE TAIL PIPE EXTENSION TO THE TAIL PIPE USING BY EITHER WELDING (RECOMMENDED FOR APPEARANCE REASONS) OR USING A 4" CLAMP (INCLUDED). YOU MAY NEED TO TRIM TO LENGTH AND STYLE OF CUT.

8) TIGHTEN ALL CLAMPS AND BOLTS AND CHECK FOR CLEARANCE OF THE FRAME, BODY, AND BRAKE AND FUEL LINES.

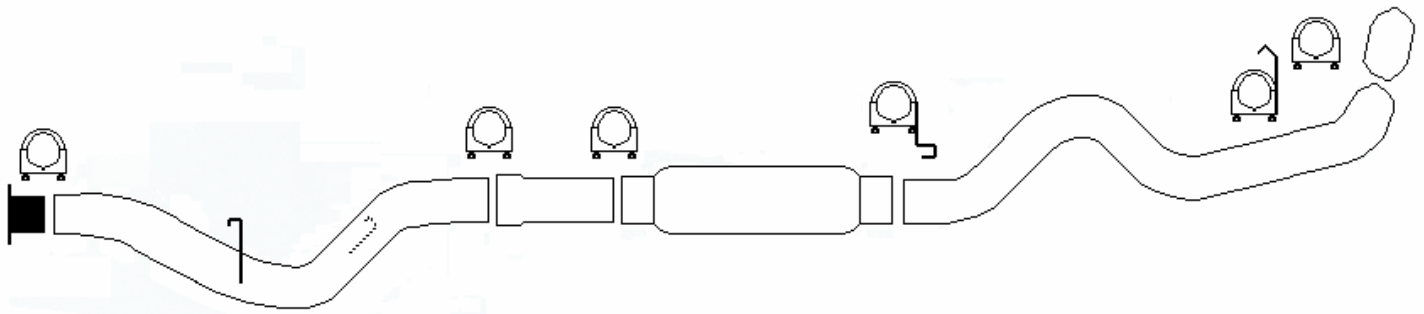
