

NOTE: DO NOT TIGHTEN ANY CLAMPS OR NUTS UNTIL THE LAST STEP!! NOTE: THIS EXHAUST SYSTEM RUNS OUTSIDE OF THE FRAME!!

- 1) REMOVE THE OLD EXHAUST SYSTEM. SAVE THE OLD EXHAUST GASKETS, SLEEVES, AND THE MANIFOLD STUDS AND NUTS FROM THE ORIGINAL FRONT PIPES.
- 2) INSTALL THE LEFT (#16541) AND RIGHT (#16542) MANIFOLD PIPES USING THE ORIGINAL GASKETS AND SLEEVES. TIGHTEN ONLY ENOUGH TO HOLD IN PLACE. NOTE: FOR VEHICLES REQUIRING CATALYTIC CONVERTERS TO MEET EPA GUIDELINES, CONVERTER PART #73-7774 OR EQUIVALENT SHOULD BE INSTALLED ON THE END OF THESE EXTENSION PIPES AND DIRECTLY IN FRONT OF THE MUFFLERS. SEE DRAWING. CONVERTERS ARE NOT INCLUDED IN THIS KIT.

- 3) INSTALL THE LEFT & RIGHT (#15541) FRONT EXTENSION PIPES TO THE MANIFOLD PIPES USING 2-1/4" CLAMPS. DO NOT TIGHTEN. SEE ILLUSTRATION FOR EXTENSION PIPE ROUTING.
- 4) INSTALL THE MUFFLERS (SINGLE OFFSET TURBO-TYPE RECOMMENDED) ONTO THE FRONT EXTENSION PIPES USING 2-1/4" CLAMPS--DO NOT TIGHTEN. DRILL A HOLE IN THE FRAME OVER THE REAR OF THE MUFFLER TO ACCEPT THE SHEET METAL SCREW PROVIDED. THIS WILL ENABLE YOU TO BOLT A 90 DEGREE 'LB' HANGER TO THE FRAME SO THAT A CLAMP MAY BE INSTALLED ALONG THE REAR OF THE MUFFLER OUTLET. ATTACH THE LB HANGERS TO THE MUFFLER OUTLETS USING 2-1/4" CLAMPS--DO NOT TIGHTEN.
- 5) INSTALL THE LEFT & RIGHT FRONT TAIL PIPES (#15542) TO THE MUFFLERS USING 2-1/4" CLAMPS. ROTATE SO THAT THEY CLEAR THE TIRES AND BODY. NOTE: THIS KIT IS DESIGNED TO FIT VANS WITH A 125" WHEEL BASE. SHOULD YOUR VAN HAVE A SHORTER WHEEL BASE, IT WILL BE NECESSARY TO REMOVE LENGTH IN THE PIPES. THIS CAN BE DONE BY CUTTING IT OUT OF THE STRAIGHT SECTION GOING INTO THE MUFFLER ON PART #15542.
- 6) INSTALL THE MID SECTION TAIL PIPES (#15543) TO THE FRONT SECTION TAIL PIPES USING 2-1/4" CLAMPS. ROTATE THE PIPES TO CLEAR THE LEAF SPRINGS.
- 7) INSTALL THE REAR TAIL PIPES (#15544) TO THE LEFT & RIGHT MID TAIL PIPES USING 2-1/4" CLAMPS. TRIM TAIL PIPES TO YOUR DESIRED LENGTH.
- 8) DRILL A 1/4" HOLE IN THE FLOOR BOARD TO BOLT THE OTHER 90 DEGREE 'LB' HANGERS AND MOUNT THE LB HANGER, GROMMET, AND LAG SCREW TO THE VEHICLE. CLAMP THE HANGERS TO THE TWO TAIL PIPES USING 2-1/4" CLAMPS.
